

About the workshop

This one-week workshop looks at the key stages in handling criminal matters once a crime has been investigated and charges brought. It will consider, from the most minor of wrongs to the most grave, how the case is handled by the judicial system and the ways in which the various people involved, the victim, witnesses and the accused, are dealt with. It will also look at how appeals are processed and possible miscarriages of justice redressed. It will examine the challenges in dealing with offenders, both in custody and in the community, and attempts to tackle recidivism and reduce reoffending.

All these challenges will be explored within the context of several years of shrinking budgets and political change. It will consider the new approaches possible through the use of digital technology in the criminal justice sector and discuss the role of independent inspection and citizen involvement.

Who is it for?

This workshop is designed for policy makers, practitioners and senior decision-makers across the justice sector. These will include:

- Judges
- Lawyers
- Court administrators
- Managers of custodial services
- Probation service leaders and those involved in the support and re-integration of ex-offenders into the community
- Policy advisers and managers from Ministries of the Interior, Home Affairs or Internal Security
- Legal and judicial reform specialists
- Human rights advocates
- Youth justice workers
- Senior social workers
- Others concerned with making the criminal justice sector work more effectively for the benefit of all citizens, to uphold the rule of law and advance speedy, fair and reliable justice

How participants will benefit

The workshop will:

- Familiarise you with the way courts function at various levels from First Instance Magistrates Courts through Crown Courts to the Supreme Court
- Expose you to the work of the prison service and probation managers
- Describe accountability and oversight arrangements
- Look at special procedures for children in custody
- Provide you with an opportunity to compare experiences of reforming criminal justice in various countries
- Help you to identify practical ways of initiating relevant and sustainable change to enhance multi-agency working in the criminal justice sector on return to your own country

What the workshop will cover

The workshop will concentrate on how criminal cases are resolved, how potential errors are dealt with and what efforts are made to reduce reoffending. It will focus in particular on the role of the courts, prisons and probation services. Issues explored will include:

- The current criminal justice reform agenda in the context of contemporary priorities
- How First Instance Courts deliver local justice
- Processes to achieve consistency in sentencing
- How performance in courts can be enhanced and delays reduced
- Ways in which possible mistakes and miscarriages of justice are tackled
- Approaches to handling offenders in custody and in society
- Initiatives to reintegrate ex-offenders into society and reduce reoffending

You will be invited to give an informal presentation on your own justice system and to talk about a particular area of criminal justice from your own country.

Workshop Director

The Workshop Director will be Neil McCallum. Neil has worked with police services, judiciaries, prosecutors and prison authorities around the world on various aspects of criminal justice reform. Recent assignments include the design and delivery of a series of capacity building workshops in Nigeria attended by over 300 Justices of the Court of Appeal and Chairs of Election Petition Tribunals, advising on the creation of a new Anti-Corruption Court in Sierra Leone, and UK based workshops for prosecutors from Qatar and judges from Sri Lanka. Neil directs annual professional development workshops with PAI on various justice sector and anti-corruption issues.

Neil is a member of the Royal African Society and the Royal Commonwealth Society. In 2017 he was elected a Fellow of the Institute of Information Management of Africa in recognition of his contribution to improvements in public sector information handling in Africa.

Language

The workshop is conducted in English. You will need to have a good working knowledge of the language.

Location and arrival arrangements

The workshop is based in central London. Visits to people who have direct experience of managing in the UK criminal justice system will be included. We can arrange travel to and from one of the London airports into central London if you let us have your flight arrival details in good time. The cost of airport transfers is included in the fee.

Fees

The tuition fee is £2,250. This includes tuition, travel to and from the airport in London, travel on scheduled visits which form part of the programme¹, presentation material and other documentation. It also includes an Android tablet for you to use during the workshop and take home with you for future follow up. We also provide a light lunch and refreshments during each working day as part of the fee.

Other costs

Airfares and daily travel to and from the workshop venue are not included. Our workshops are non-residential and you are responsible for your accommodation costs. We can help you with booking hotel accommodation so please let us know if you would like us to advise you or make a reservation. We suggest that you should allow approximately £160 per day for a modest standard of hotel (for example, three-star), local travel in the UK, meals (apart from a light lunch on working days) and other incidental expenses.

Value Added Tax

We do not have to charge UK Value Added Tax (VAT) if you can provide written confirmation from your government or its accredited representative that you are "employed by the government in furtherance of its sovereign activities". In all other cases, we will have to charge VAT (currently 20%) in addition to the fee.

Ways to pay

You, or your government agency, can pay by bank transfer or by cheque, made payable to Public Administration International. We accept payment by credit or debit card but there is a surcharge for this way of paying. Please contact us if you would like to pay by credit or debit card.

Discounts

We offer a 10% reduction on the full tuition fee if we receive payment no later than 28 days before the first day of the workshop. If we receive payment after that, we will charge the full tuition fee.

Cancellation

If you have to cancel your booking, you must let us know in writing and we will acknowledge in writing your cancellation. For cancellations received up to 29 days before the start of the workshop we will refund the tuition fee, minus a charge of £200 to cover our administration costs. For cancellations received within 28 days of the start of the workshop, we will charge the full tuition fee. If you have paid the tuition fee and have subsequently been refused a visa to enter the UK, we will refund the tuition fee, minus a charge of £200 to cover our administration costs, providing you send us the original letter from the British High Commission/Embassy confirming refusal of a visa and providing you have not entered the UK.

Substitutions and transfers

If you have booked a place on a workshop and are not able to attend, we will accept a substitute at any time without penalty but our normal terms and conditions will apply. Also, it is possible to transfer to a future workshop but only one transfer is permitted. Please get in touch with us and we will advise you about transfers.


