About the workshop

Governments cannot make or implement policies effectively without communicating them, both through traditional news media and social media. However, as we see more divided communities and fragmentation of public consensus, rapid changes in the media marketplace make communication ever more challenging for Ministries, their advisers and officials, as well as for professional communicators. This workshop will help you tackle these challenges by discussing the strategic basis of good communication and how the UK Government in particular aims to apply both to digital and more traditional media.

The workshop includes visits to major international news organisations (e.g. BBC World Service and Reuters) and discussions with senior journalists, government communicators and experts in social media and stakeholder analysis. Throughout the workshop, you will also work with other participants on an exercise designed to help you to practise these new approaches and techniques to develop a positive image for your government.

Who is it for?

This workshop is designed for those in high-profile government communication and information roles (such as heads of communication and press and marketing officers), political and general editors from national newspapers, broadcasting organisations and news agencies and spokespeople from political parties and non-government organisations. The workshop will also benefit others responsible for communicating with the public.

How participants will benefit

The workshop will:

- Develop your knowledge of how government and other public organisations use communications to help devise and deliver effective policies and programmes
- Help you to learn from the experience of UK government communicators and of leading journalists and editors, including how to raise awareness of the importance of communications in your own organisation
- Encourage you to consider ways of using a range of media and different messengers to widen access to public information and reach fragmented audiences
- Raise your awareness of how to handle public communication and apply strategic communication techniques to improve the image of your government
- Establish good practice across the works as you share experience from your country with others in comparable situations.

What the workshop will cover

This workshop will review:

- Traditional and social media, including digital broadcasting
- Government priorities in managing public communication and the political dimension of dealing with diverse interests
- News media priorities, public interest and freedom of information
- The role of public relations and marketing professionals in media management and image promotion.

The workshop will include presentations and discussions, briefings by government communicators, editors and journalists, and group visits to media and government organisations. You will have the opportunity to discuss practical issues affecting your own professional life and to compare and contrast experience with counterparts from different countries.

Workshop Director

The Workshop Director will be Ian Cameron. Ian is an international media and communications consultant, combining 35 years' broadcast experience as a reporter, producer and news editor in the BBC and ITV with the academic rigour needed for a Masters' Degree in Civil Protection. He's a NATO Civil Expert in risk communication and media and a member of NATO's core planning team for major exercises involving 1200 people and 30 nations; a consultant and associate trainer at the UK Emergency Planning College and a member of the National Steering Committee for Warning and Informing the Public, which advises the UK Government.

As well as covering and coordinating news coverage for the BBC, Ian was also a member of the BBC Business Continuity and Disaster Recovery Team. He was a member of a team that trained 500 BBC staff to become video journalists and he also taught video literacy at TV4 and TV3 in Sweden and Denmark. He was part of the Emergency Management Improvement Programme at the Sellafield Nuclear Decommissioning and Reprocessing Plant. He has also been involved with a number of EU projects, including the PACE exercise involving 30 ambassadors, EDEN CBRNe Project, SPRES Oil Pollution Project and the AWARE programme about cross-border cooperation during a crisis.

Language

The workshop is conducted in English. You will need to have a good working knowledge of the language.

Location and arrival arrangements

The workshop is based in central London. We can arrange travel to and from one of the London airports into central London if you let us have your flight arrival details in good time. The cost of airport transfers is included in the fee.

Fees

The fee for this one-week workshop will be £2,240. It includes tuition, travel to and from one of the airports in London, travel on scheduled visits which form part of the programme¹, presentation material and other documentation. It also includes a Android tablet for you to use during the workshop and take home with you. We provide a light lunch and refreshments during each working day as part of the fee.

Other costs

Airfares and daily travel to and from the workshop venue are not included. Our workshops are non-residential and you are responsible for your accommodation costs. We can help you with booking hotel accommodation so please let us know if you would like us to advise you or make a reservation. We suggest that you should allow approximately £160 per day for a modest standard of hotel (for example, three-star), local travel in the UK, meals (apart from a light lunch on working days) and other incidental expenses.

Value Added Tax

We do not have to charge UK Value Added Tax (VAT) if you can provide written confirmation from your government or its accredited representative that you are "employed by the government in furtherance of its sovereign activities." In all other cases, we will have to charge VAT (currently 20%) in addition to the fee.

Ways to pay

You, or your government agency, can pay by bank transfer or by cheque, made payable to Public Administration International. We accept payment by credit or debit card but there is a surcharge for this way of paying. Please contact us if you would like to pay by credit or debit card.

Discounts

We offer a 10% reduction on the full tuition fee if we receive payment no later than 28 days before the first day of the workshop. If we receive payment after that, we will charge the full tuition fee.

Cancellation

If you have to cancel your booking, you must let us know in writing and we will acknowledge in writing your cancellation. For cancellations received up to 29 days before the start of the workshop we will refund the tuition fee, minus a charge of £200 to cover our administration costs. For cancellations received within 28 days of the start of the workshop, we will charge the full tuition fee. If you have paid the tuition fee and have subsequently been refused a visa to enter the UK, we will refund the tuition fee, minus a charge of £200 to cover our administration costs, providing you send us the original letter from the British High Commission/ Embassy confirming refusal of a visa and providing you have not entered the UK.

Substitutions and transfers

If you have booked a place on a workshop and are not able to attend, we will accept a substitute at any time without penalty but our normal terms and conditions will apply. Also, it is possible to transfer to a future workshop but only one transfer is permitted. Please get in touch with us and we will advise you about transfers.


